FOOD PROCESSING SECTOR IN INDIA

India's food processing sector has shown robust growth, reaching a valuation of **USD 389 billion in 2025** and is projected to reach **USD 535 billion by 2025-26**, supported by rising consumption, especially in Tier-II and Tier-III cities, government initiatives, and exports growth. The sector contributes significantly to India's economy, representing about **8.9% of agriculture Gross Value Added (GVA)** and playing a vital role in employment with approximately 2.23 million workers in registered units and an additional 4.68 million in unregistered segments.

Government support through schemes like the Production Linked Incentive Scheme for Food Processing Industry (PLISFPI) with an outlay of **₹10,900 crore (2021-22 to 2026-27)**, PMKSY, and mega food parks has strengthened infrastructure, cold chains, and formalisation of food business operators, increasing from **25 lakh to 64 lakh** units recently. The sector is embracing **innovation with investments in AI, smart packaging, organic foods, and plant-based products**, driven by evolving consumer preferences and health consciousness.

India is a top global producer of key agricultural products, positioning the food processing sector for considerable expansion domestically and globally. Agricultural and processed food exports touched **USD 49.4 billion in 2024-25** with processed food's share rising from **13.7% in 2014-15 to 20.4%**.

This data reflects ongoing transformation and government focus, making the sector a critical growth driver in India's economy.

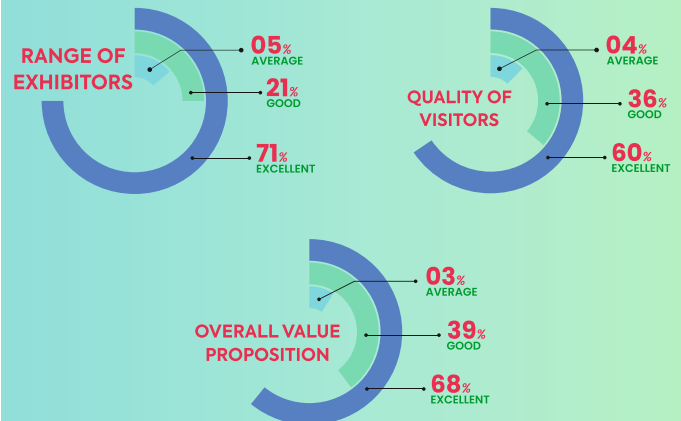

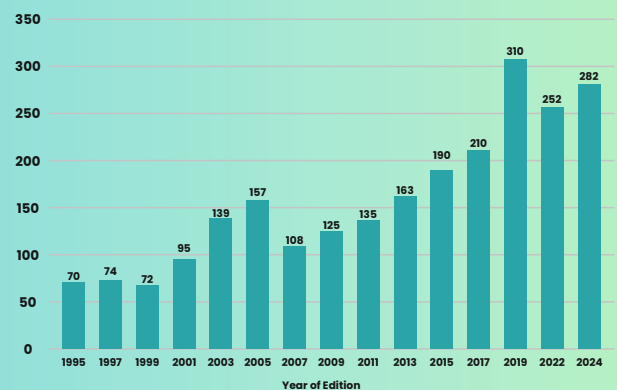

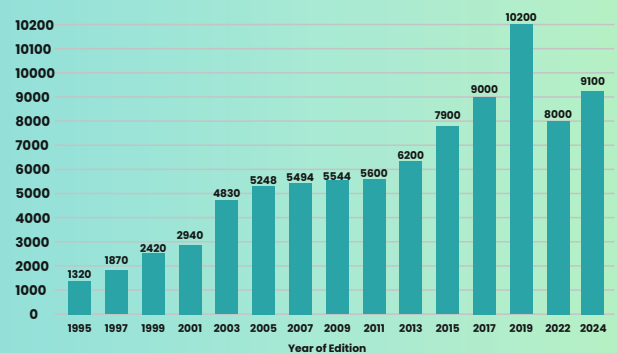

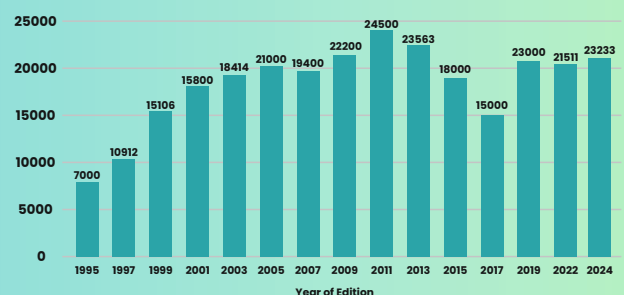
FOODPRO OVER THE YEARS
